The Health and Safety Act will be renumbered in April 2020. A draft table of concordance was provided. Structure changes will be coming to WorkSafeBC in 2020. The internal working group has been defined and meetings have taken place regarding

the Confined Space regulation change. WorkSafeBC has approved sponsorship for BCWWA conference. Violence in the Workplace working group pre-committee work is being expedited.

Kim Stubbs:

Situational awareness with aquatic workers highlighted in upcoming WorkSafeBC magazine. WorkSafeBC will be re-evaluating the content of the BCRPA 3 hour pool safe course in 2020.

Sub Committee Reports

Ed TAC: Sergio Picco – 6 training new training videos have been created. In 2019 5 mental health rtw regional training sessions happened. Upcoming webinars include A Systems Approach to MSI's on December 12, 2019 and Depression Symptoms & Support January 23, 2020. Looking for new members to the group.

RTW App Working Group – Demo of product. Looking for Disability Managers and Health and Safety Managers to act as committee members .

Round Table

- Tracy Wynnyk, MOTI – 2019 BCMSA training well received. 75% field services employees have taken training. 2020 version of traffic management manual updated and will be distributed in January 2020. Change record will go out with the document.
- Coreen Wolanski, BC Public Service Agency – In 2012 round of correctional center audits were completed. In 2016 it was repeated and in 2019 4 centers were audited resulting in 17 orders total related to respiratory protection or documentation, violence prevention, bodily fluid and sharps disposal. Ministry of Environment completed a gap analysis audit of SMS with the potential for COR certification in the future.
- Andrew Ross, City of Vancouver – Fatality under investigation with WorkSafeBC and RCMP. Trailing procedure reminders; ensure you have good quality chocks and have completed tug tests. Received a gas hits order. Creation of a new safety policy in November with launch of an internal website.
- Sam Chauhan, City of Surrey – A worker was working at a Civic facility on a 40 ft roof with no safety monitor zone. Provided clarification on fall protection requirements to staff. Didn't establish safety monitor zone.

- Nela Graham, Metro Vancouver – Renewal of confined space systems and processes including confined space observation checklists for supervisors with quotas. Expanded waste transfer station dirty bin expanded to all transfer stations in GVRD for residential construction debris. Special bags available, bags have instructions and video to help. New training program to help non arborist complete brush clearing and assist in identifying what is a tree. MVI reduction initiative. Biogas initiative – working with WorkSafeBC and defining what fire protection PPE is appropriate.
- Sergio Picco, City of Burnaby – COR audit complete and working on action items. Asbestos program happening in 2020. Substance use policy update and training. Pool Janitor exposure incident resulted in a 1-week LTI.
- Charity Igiri, City of Pitt Meadows – Closing out orders as a result of the program and committee effectiveness initiative. November 2019 – closed out all action and received letter of compliance.
- Candice Roffe, City of White rock – Implemented a working alone procedure utilizing a 3rd party service. Receiving about one false call a week. Electrical lockout procedure at pump stations. Water treatment plant up and running this year.
- Sandra Ciparis, Township of Langley – Completing assessments to ensure proper licensing for heavy trailer endorsement (code 20) where needed. Fire department issue. WorkSafeBC wants an engineer report for access which is problematic in emergency situations. Working towards a solution. Completed COR audit and working on action items.
- Dave Lovely – Acknowledged importance of the BCMSA supervisors’ safety program. With staff turnover they are noticing more incidents with newer staff that have not completed the program. Looking for fitness for duty trainers.
- Parm Phangura, City of Abbotsford – Completed COR audit, rolled out working alone process utilizing a 3rd party vendor. Received a final warning letter regarding a training program and a combustible fire.
- Dave Richards, City of Richmond – Transportation of Dangerous goods training and experiencing problems with confined space and lockout procedures.
- Peter Lyons, District of Mission – Situational awareness with lifeguards and young staff have led to some injuries. Fire department training can’t meet operational training requirements because of scheduling issues, working towards a solution. Utilizing a 3rd party working alone service provider but having occasional issues in areas that don’t have cell service.
- Lidia Grzesiuk, City of North Vancouver – Experienced a tandem truck and boulder incident resulting in medical aid and issues with shipyards freezing.
- John Weloy, City of Burnaby – Homeless camp cleanup projects with cleanup consultant. RFP for asbestos management. Recent changes to ICBC insurance requirements have implications for staff with class 5 licenses driving for work purposes.

- Mike Roberts, BCMSA - Local roadways manual – looking at possibility of a working group to develop a local roadways manual (Health and Safety Managers and Traffic Department Engineers) (Surrey, Vancouver, Kamloops, Coquitlam, Burnaby having a preliminary feasibility meeting in January 2020. Yahoo user group – new forum in progress and will be out in early 2020. December newsletter coming out in the next two weeks. 2020 conference in Richmond this year capping at 400-450 so register early. AGM will be in June in 2020.
