## **U** The Power of a SCADA Master Plan: A City of Courtenay Case Study

The water and wastewater pumping and distribution stations in the City of Courtenay were previously operated independently with no overarching Supervisory Control and Data Acquisition (SCADA) system that tied the system together for a system-wide control, monitoring, alarming, and reporting. PBX Engineering collaborated with the City for the delivery of the SCADA system, commencing a Master Plan study and completing with the commissioning of the systems. This interactive presentation includes a case study examining the planning, development and deployment of the City's region-wide SCADA system and review of the obstacles. Delegates will experience a demonstration of the SCADA system using a number of tablet devices.

Historically, smaller rural communities could not afford technology options to capture and analyze their road data. The City of Temiskaming Shores in Northern Ontario partnered with StreetScan to take advantage of new efficiencies in this field. This case study reviews their innovative approach to collect data on road and other assets; highlight advanced decision-making software used to provide data for budget decisions using historical data and complimentary data sets; and share information about how to qualify for an 80% grant up to \$50,000 from FCM for asset management.

Autonomous Vehicle (AV) technology is rapidly emerging and is poised to represent a US\$42 Billion global market by 2025. Over the next several years, industry analysts expect fully autonomous vehicles to be available for purchase with market adoption occurring over the next 30 years. To understand the scope of these changes, Urban Systems conducted a nation-wide public survey that generated over 700 responses. A wide-cross section of respondents, from large cities to rural areas, representing all adult age groups, provided insights on how they would use autonomous vehicles when they become available.

**U****Waterproofing Bolted Steel Reservoirs**

Duncan's 35 year old Steel Potable Water Reservoir is impacted by fire and is no longer holding water. The reservoir purpose is to supply water and maintain pressure and volume for fire supply. The challenge: how do you waterproof a forty-foot diameter bolted steel tank built in the 70's with an identified 240+ holes. In addition, the repair must maintain a long-term seal with continuous thirty-five feet of head pressure. Learn how new technologies utilizing both structural foam and polyurea linings can water proof even the most challenging problems.

### U Organic Waste - The Trials and Tribulations of Turning Toxic Trash into Treasure

Pressure to reduce waste production and increase the use of substances that were traditionally viewed as waste is increasing. The use of some of these materials (e.g. yard waste) is more socially acceptable than others (e.g. sludge/biosolids). Unfortunately, the sludge/biosolids aspects continue to become more complicated with the drive for higher effluent quality being confounded by the lack of desire for land application. Organic wastes are often viewed separately, but streamlining is possible through co-treatment. This presentation will explore the issues related to different organic wastes, unravel some myths and misunderstandings related to sludge/biosolids, and provide direction as to the pathways for turning these wastes into resources.

### L 30/30 Respect and Violence in the Workplace

### S High Risk Strategies and Initiatives

WorkSafeBC'S High Risk Strategies identify and target industries and employers with a high risk of serious workplace injury and a significant contribution to the serious injury rate. Based on the incidence of serious injuries and work-related deaths, the High Risk Strategies include four industry sectors: construction, forestry, health care, and manufacturing. Collectively, the High Risk Strategies are designed to reduce the serious injury rate through implementation of risk-reduction tactics directed towards high-risk work activities. The primary role of the High Risk Strategies is to identify categories of serious injuries and to develop planned approaches to effect change, thereby reducing the risk of serious injuries. Each strategy focuses prevention initiatives on identified areas of high risk in order to apply resources and effort where they will be most effective.

WorkSafeBC's Industry Initiatives identify additional sectors and subsectors, outside of the High Risk Strategies, with a high risk of serious workplace injury and significant contribution to the serious injury rate. Of the twelve industry initiatives identified for 2018, the following are relevant to the Municipal sector:

- Asbestos – commercial
- Asbestos – residential
- Lead, silica sensitizer, solar, and welding fumes
- Confined space
- Bullying, harassment and discrimination

### Sun Peaks Wastewater Treatment Plant and Composting Site

Transportation: Via Carpool. Please meet in the lobby of the Sun Peaks Grand by 8:15am. Please bring your vehicle if possible. Each site is within 5 minutes of the Grand Hotel.

Waste Water Treatment Plant - Sun Peaks Utilities collects via a gravity collection system and then treats all the wastewater for the resort community of Sun Peaks. Sun Peaks Utilities' Wastewater Treatment Facility uses a Biological Upward Flow Sludge Blanket Filtration design (USBF - modified activated sludge process) to treat all the wastewater prior to discharging the treated effluent to Rapid Infiltration Basins. Pat will also provide an update on the liner replacement project that is currently in progress.

Composting - The wasted treated bio-mass from the treatment process is dewatered and then composted using an In-Vessel process with pine wood chips as the carbon source. A Class A compost has been in place since August 2012. At this time, only the wasted bio-mass is being composted. The In-Vessel Composting System does have the ability to take other waste products and turn them into compost sometime in the future.

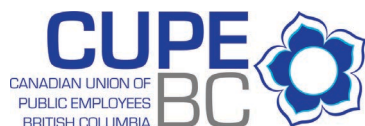
