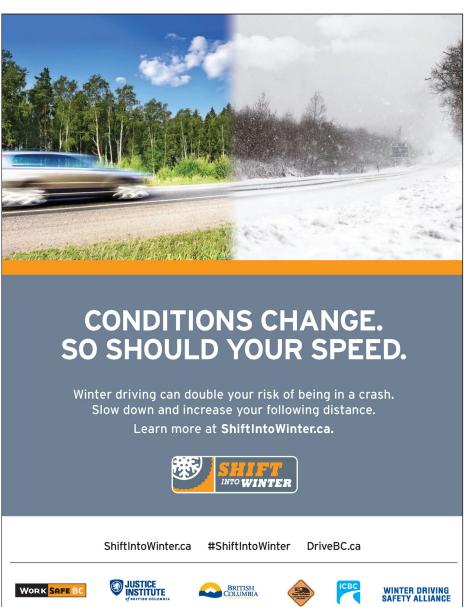

The Government of B.C. has confirmed that changes to the language and numbering of the Workers Compensation Act will come into effect on April 6, 2020.

# BCMSA YEAR IN REVIEW - TRAINING AND COR

The year of 2019 has been a milestone year for the BCMSA. In 2019, the BCMSA ran over 1000 in-person training sessions, an increase of over 350 sessions in just 3 years! This is a feat that all of us at the BCMSA are extremely proud of, and it would not be possible without the continued support of our membership. As always, we are extremely thankful to our membership for continuing to choose the BCMSA as their resource of choice.

The BCMSA also launched 5 new training courses in 2019:

- Fatigue Management: Sr. Leadership/Management
- Fatigue Management: Supervisor/Health and Safety Committees
- Mental Health Return to Work for Supervisors Training
- TCP Requalification (1-day training)
- · TCP Requalification (2-day training)

Each of the 5 courses launched above have been met with an extremely positive response, and we have already begun booking each of these courses into 2020.

The BCMSA anticipates training to continue to grow in the coming year, so please get your bookings in now to reserve training for your organization!

The COR side of business for the BCMSA has been equally eventful in 2019. The BCMSA has 42 organizations currently certified through the COR program, and have received keen interest from potentially 5 new organizations looking to take part in the program in 2020. The BCMSA is also currently engaged with WorkSafeBC and other certifying partners in reviewing and updating the COR program. The BCMSA will continue to provide updates and communicate all changes to the COR program to our clients as they come to fruition.

# NEW COURSE COMING SOON IN 2020 RESILIENT MINDS: BUILDING THE PSYCHOLOGICAL STRENGTH OF FIREFIGHTERS



The Canadian Mental Health Association (CMHA) and the BC Municipal Safety Association (BCMSA) have partnered to engage and inform firefighters in four areas crucial to their work: building psychological resiliency, trauma, psychological distress, and traumainformed responses. This will be achieved through BCMSA offering CMHA's program to both volunteer and career municipal firefighters across the province.

Resilient Minds is a new workshop originally developed in a partnership between CMHA and the Vancouver Fire and Rescue Services. It was developed in response to the disturbing experience of firefighters and stress-related injuries. Resilient Minds uses CMHA's "4R Action Toolkit" to build

skills needed to reduce personal risks related to psychological impacts, and assist members of the public, colleagues and family who may be struggling with a mental health problem or be in a crisis

# HOW TO GET THE MOST OUT OF YOUR JOINT HEALTH & SAFETY COMMITTEE

If your workplace has 20 or more workers, you are required to have a Joint Health and Safety Committee. A well-run Joint Health and Safety Committee (JHSC) is an important part of your occupational health and safety program, and gives workers and employers a way to work together to identify and find solutions to workplace health and safety issues. Having an effective JHSC also sends a strong message that the safety and well-being of your staff are valued.



### Your role in health & safety

As an employer you have a responsibility to ensure the effectiveness of your JHSC and its role in health and safety in your workplace. While the JHSC contributes to workplace health and safety, the employer ensures that you have buy-in on all levels by integrating health and safety into day-to-day activities.

For example, Metro Vancouver has multiple JHSCs, and to show support and understanding of the importance of these committees, the corporation created a one-day conference that brings them together for knowledge sharing. This platform creates a valuable networking opportunity for committee members to join together with their peers across the organization and emphasizes how much the organization values health and safety in the workplace.

Effective committees are the driving force behind new or revised health and safety policies and procedures. Some of the smallest, simplest ideas can produce the biggest results. Take a look at these other suggestions to get the most out of your Joint Health and Safety Committee:

- Get the right people involved. The committee should include workers who represent the composition of the workplace. The employer representative should be a person with the authority to influence or make decisions about health and safety matters.
- Extend the members terms of office. For example, increase the tenure to 2 or 3 consecutive years. As members remain on the committee, they grow and gain experience.
- All JHSC members should receive adequate training and education to effectively fulfil their duties and functions. This includes required annual training and updates to legislation and other regulatory requirements that may impact the workplace.
- Develop and regularly review the JHSC Terms of Reference.
- Recognize and reward the JHSCs work.
- Show support for the activities of the JHSC by allowing time for meeting preparation and attendance.
- Keep JHSC notice boards up to date and current.
- f your organisation has multiple JHSCs, determine a process for communication between the committees.
   This may mean applying to WorkSafeBC for a variation in committee structure.
- Conduct effective JHSC meetings (e.g. all members to receive an agenda ahead of time, actively participate in discussions, and carry out delegated committee work).
   Co-chairs can schedule guests to attend meetings to answer questions on topics discussed, or act as a subject matter expert for clarification on an issue.
- Annually evaluate the effectiveness of your JHSC.
   Annual reviews are to determine whether the committee is compliant and to assess whether it has been effective in fulfilling its role.

By following these key guidelines, you can ensure that your JHSC is key part of a safe and well-functioning workplace.

## INTERNAL AUDITOR TRAINING

This two day course is for staff from local governments or naturally-aligned organizations who wish to learn more about how the COR audit is conducted. Participants wishing to become certified Internal Auditors must successfully complete a student audit within three (3) months.

In order to maintain certification, two (2) maintenance Internal) audits and seven (7) hours of approved training must be completed within 3 years of Internal Auditor Certification.

Prerequisite for Internal Auditor Training: Safety Management Systems

A Health and Safety Management System is a comprehensive in-depth approach that addresses all aspects of an organization's operations from a health and safety viewpoint and involves management and workers in a meaningful way. An organization wishing to pursue COR must have had the CAO or another manager participate in a Safety

Management Systems course.

# **ABOUT COR**

The Certificate of Recognition (COR) program rewards employers who have developed and implemented safety management systems against industry based standards. It provides an opportunity for employers and safety associations to take a proactive role in promoting health and safety. Employers can reduce injuries and accidents in the workplace, reducing worker suffering and improving the workplace safety culture. Achieving and maintaining a valid COR is required for earning an annual incentive payment from WorkSafeBC.

Certificates are issued by WorkSafeBC and are co-signed by the Certifying Partner. The BCMSA is the Certifying Partner for employers in the Local Government Classification Unit and is responsible for the creation of the Local Government Audit Tools, Training and Certifying External and Internal Auditors, and overall quality assurance of the program.

# FINDING COMMON GROUND ON DIGGING SAFETY

Underground infrastructure damage costs Canadians \$1 billion each year, and 80% of damages cause service disruptions, according to the BC Common Ground Alliance (BCCGA). But the biggest concern is the safety risk to residents and workers.

#### Excavation safety is a joint responsibility

The BCMSA has a strong relationship with <u>FortisBC</u>, paving the way for successful, collaborative safety initiatives across the province.

"We all share the goal of keeping our workers, customers and the general public safe around electricity and natural gas, so it makes sense for us to join forces with municipalities," says FortisBC public safety manager Michelle Petrusevich. "We keep each other informed and look for opportunities to work together."

BCMSA executive director Mike Roberts added, "Along with all the fantastic work FortisBC is undertaking with our communities, the BCMSA continues to provide valuable education and resources for workers across the province who work around utilities and perform excavation work."

#### Educational efforts increasing across BC

The BCMSA offers a number of educational sessions and resources around utilities and ground disturbance such as utility awareness for municipal workers, utility locator specialist training and two different shoring and excavation courses.

FortisBC works with BCCGA, BC One Call, BC Hydro, TransMountain, Shaw and other organizations to deliver ground disturbance training sessions across the province. This all-day education session teaches professional excavators everything they need to know about safe digging—crucial information for those who work around underground infrastructure every day.

"Our partnerships are clearly working," Michelle says. "This year, FortisBC also teamed up with the City of Kelowna to educate citizens and staff about energy safety. As a result, the City of Kelowna received the 2019 BCCGA City of Excellence Award for their efforts in following safe underground disturbance practices. We look forward to more collaborations with BC municipalities, helping to keep our communities safer."
