ORGANIZATIONAL SAFETY EXCELLENCE

Objective of the Award: To recognize local governments for activities that improve experience rating, and ultimately reducing injuries, illness, disease and fatalities. To be eligible, an organization must meet one of the two following criteria:

-The current experience rating is in a discount position with a consistent experience rating discount of -20% or more over a three-year period, or

-A reduction of 20 percentage points in the past 4years and has to be in a discount by the end of the most recent three-year period..

Objective of the Award: To recognize local governments for activities that improve experience rating, and ultimately reducing injuries, illness, disease and fatalities. 






TRAINING & COR UPDATE

JUSTIN CHOUHAN

The first half of 2021 has had its set of challenges for the BCMSA as we continue to live through the global pandemic that is COVID-19. As the world continues to change amongst us, so has the way we operate here at the BCMSA.

Our in-person training portfolio almost entirely transformed into a virtual model that has been widely accepted by the municipal sector throughout British Columbia, In attempt to support municipalities across the province, the BCMSA has continued to schedule monthly open-enrollment virtual training sessions throughout the year for those organizations that may not have enough students to run an internal training session. As a result, we have been able to connect with numerous new City's, Districts, Towns and Villages throughout province. A silver lining of the pandemic is the number of new relationships that were built with organizations that needed support and which will allow the BCMSA to increase our reach to

support local government across all of BC – something that has always been part of our strategic plan here at the Association.

The BCMSA also partnered with My Workplace Health to carry forward the Psychological Health and Safety Certificate Program for local government. There has been extreme interest within the industry around this certificate and the BCMSA is committed to servicing the membership through 2021 and beyond. I

would also like to congratulate the City of Burnaby as their Senior Management team was the first cohort within local government to complete the Senior Leaders Certificate for our Psychological Health and Safety Program.

Unimaginably, our training in the first half of 2021 has exceeded the number of courses booked in the first half of 2019 – our greatest training year to date. I am extremely proud of the

profound work the BCMSA has done in both 2020 and 2021 which has exceeded even our own expectations.

The COR program continues to function as is for the time being and a Proof of Concept will take place in November within the Municipal Sector which will pilot a re-vamped COR process. This pilot will include auditing against a new COR Standard while using a unified COR Audit Tool amongst all Certifying Partners. The BCMSA also ran it's first ever Virtual Internal Auditor training Session in May which was met with an extremely positive response. Going forward, Internal Auditor training will be offered both in-person and virtually to allow organizations residing outside the lower mainland to attend without travelling. As always, the BCMSA will continue to provide COR updates and communicate all changes from the COR program to our members and clients.

I am also extremely thankful for how our industry has been able to care for each other throughout the pandemic. The BCMSA could not have achieved this level of successes without the contribution and continued support of our membership.

CLEARING THE AIR ON TOXIC PROCESS GASES


Water treatment plants, swimming pools, and other facilities need proper exhaust ventilation when using "toxic process gases" like chlorine, ozone, ammonia, and sulfur dioxide.

It's not uncommon to see reports in the media about small chlorine leaks at swimming pools. Those often happen when chlorine gas is produced inadvertently from an improper mix of pool chemicals. Lifeguards and pool staff evacuate unsuspecting swimmers and the fire department arrives. When the safety system works, the risk of serious injuries is reduced.

But a major leak could be catastrophic. If a larger amount of a toxic process gas (TPG) like chlorine enters the general ventilation system, more people could be exposed to significant levels of it. That is why it is important for municipal facilities to install, maintain, and operate ventilation systems that move leaked gases away from workplaces, patrons, and the public.

Reducing risk before harm is done

Employers need to be aware of the risks of TPGs. Prevention officers from WorkSafeBC's Risk Analysis Unit (RAU) are engaging water treatment plants that use chlorine and other TPGs for disinfection, as part of an ongoing inspection initiative. In addition to inspecting, the RAU is providing employers and their workers with resources to assist with the development and maintenance of safer environments for workers, patrons, and surrounding communities. RAU's approach combines education, consultation, and enforcement. Ultimately, the goal is to raise awareness and minimize risk before harm is done.



Toxic process gas enclosures

Water treatment plants and other facilities using TPGs need enclosures (sealed rooms) that house all toxic process gas-containing components of their systems, including gas cylinders, pipes, tubing, regulators, valves, and plumbing for injecting chlorine into water. The TPG enclosure must have its own dedicated exhaust system — separate from the rest of the building. To ensure safety in the event of a leak, exhaust should exit the building directly, going straight from the enclosure to the outdoors. The ductwork should never pass through adjacent indoor work areas.

Exhaust fans positioned outside building

The placement of exhaust fans outside of the building is another important feature of an effective ventilation system. The fans need to be outside of the building to keep the exhaust ducts under suction (negative pressure), which causes the exhaust to be sucked out of the building. If an exhaust fan is located within a building, any cracks or gaps in the ductwork could allow TPG-containing exhaust to be discharged back indoors.

Exhaust stack extended above building

The exhaust must be discharged away from the fresh air intakes of the building — and of any other buildings nearby. This calls for an exhaust stack that extends well above the building, so that any emissions can be dispersed into prevailing winds, away from workplaces and people below.

Workers are encouraged to speak with their supervisor or safety committee representative if they have any concerns about working with chlorine or any other TPG. Employers are advised to talk with their ventilation service suppliers and to get more information about handling any TPGs used in their businesses.

INTERNAL AUDITOR TRAINING

This two day course is for staff from local governments or naturally-aligned organizations who wish to learn more about how the COR audit is conducted. Participants wishing to become certified Internal Auditors must successfully complete a student audit within three (3) months.

In order to maintain certification, two (2) maintenance Internal) audits and seven (7) hours of approved training must be completed within 3 years of Internal Auditor Certification.



ABOUT COR

The Certificate of Recognition (COR) program rewards employers who have developed and implemented safety management systems against industry based standards. It provides an opportunity for employers and safety associations to take a proactive role in promoting health and safety. Employers can reduce injuries and accidents in the workplace, reducing worker suffering and improving the workplace safety culture. Achieving and maintaining a valid COR is required for earning an annual incentive payment from WorkSafeBC.

Certificates are issued by WorkSafeBC and are co-signed by the Certifying Partner. The BCMSA is the Certifying Partner for employers in the Local Government Classification Unit and is responsible for the creation of

the Local Government Audit Tools, Training and Certifying External and Internal Auditors, and overall quality assurance of the program.
